PROFIL PRODI HUKUM UNIVERSITAS JANABADRA



Fakultas Hukum Universitas Janabadra berada di lingkungan Universitas Janabadra yang bernaung dibawah Yayasan Perguruan Tinggi Janabadra dan berkedudukan di Yogyakarta dengan berasaskan Pancasila dan Undang-Undang Dasar 1945 dengan jati diri Nasionalisme dan Patriotisme dan berwawasan Kebangsaan. Fakultas Hukum didirikan bersamaan dengan berdirinya Universitas Janabadra, yang awalnya bernama Perguruan Tinggi Janabadra yang didirikan pada 7 Oktober 1958 oleh para tokoh pendidikan dan tokoh masyarakat. Pendiri Universitas Janabadra antara lain: **Mr. KPH. Soedarisman Poerwokoesoemo**, yang sekaligus sebagai Rektor Pertama Universitas Janabadra. Pada awal pendirian Prodi Hukum berstatus Terdaftar, Kemudian pada tahun 1991 memperoleh status "**Disamakan**" berdasarkan Surat Keputusan Menteri Pendidikan dan Kebudayaan Nomor 0697/O/1991 tanggal 31 Desember 1991. Pada tahun 1998 berdasarkan Surat Keputusan Badan Akreditasi Nasional Perguruan Tinggi Departemen Pendidikan dan Kebudayaan Nomor 001/BAN-PT/AK-1/VIII/1998 tanggal 11 Agustus 1998, Prodi Hukum memperoleh akreditasi dari Badan Akreditasi Nasional (BAN) dengan peringkat **B**. Kemudian pada tahun 2003 memperoleh status "**Terakreditasi B**", Sesuai dengan Surat Keputusan Badan Akreditasi Nasional Perguruan Tinggi Departemen Pendidikan Nasional Nomor 036/BAN-PT/AK-VII/S1/X/2003 tanggal 10 Oktober 2003. dan Berdasarkan Surat Keputusan BAN-PT No: 204/SK/BAN-PT/Akred/S/II/2019 tanggal 26 Februari 2019, peringkat **Akreditasi Prodi Hukum naik menjadi A**.

*The Faculty of Law, Janabadra University is in the Janabadra University environment, under the auspices of the Janabadra Higher Education Foundation, and is based in Yogyakarta with the principles of Pancasila and the 1945 Constitution with nationalism and patriotism and nationalism in mind. The Faculty of Law was founded at the same time as the establishment of Janabadra University, originally named Janabadra College, launched on October 7, 1958, by educational leaders and community leaders. Janabadra University founders include **Mr. FMU Soedarisman Poerwokoesoemo**, who is also the first Chancellor of Janabadra University. At the beginning of the establishment of the Law Study Program, it had the status of Registered. In 1991 it obtained the status of "Equalized" based on the Decree of the Minister of Education and Culture Number 0697/O/1991 dated December 31, 1991. In 1998 based on the Decree of the National Accreditation Board for Higher Education, Ministry of Education and Culture Number 001/BAN-PT/AK-1/VIII/1998 dated August 11, 1998, the Law Study Program obtained accreditation from the National Accreditation Agency (BAN) with a **B** rating. Then in 2003, it acquired the status of "**Accredited B**" by the Decree of the National Accreditation of Higher Education Ministry of National Education Number 036/BAN-PT/AK-VII/S1/X/2003 dated October 10, 2003. and Based on BAN-PT Decree No: 204/SK/BAN-PT/Akred/S/II/2019 on February 26, 2019, the Accreditation rating of the **Law Study Program has risen to A**.*

Tenaga Pengajar Fakultas Hukum Universitas Janabadra memiliki kualifikasi pendidikan yang sangat memadai, baik dari aspek Pendidikan maupun kompetensi di bidang hukum. Pada saat ini Fakultas Hukum Universitas Janabadra memiliki **11 orang dosen yang berkualifikasi S3** dan **26 dosen berkualifikasi S2** yang diberbagai cabang ilmu hukum seperti Hukum Pidana, hukum Perdata, Hukum Tata Negara, Hukum Administrasi Negara, Hukum Internasional dan Hukum Bisnis. Beberapa dosen memiliki Kompetensi di bidang lain sebagai: Advokat, Mediator, Auditor Hukum, Ahli Perancang Kontrak (Contract Drafting, Legal Drafting, dan Konsultan Hukum Pasar Modal.

*Lecturers at the Faculty of Law, University of Janabadra, have adequate educational qualifications and competence in law. At the time, the Law Study Program of Janabadra University had **11 lecturers with doctoral qualifications** and **26 lecturers with master qualifications** in various branches of law, such as Criminal Law, Civil Law, Constitutional Law, State Administrative Law, International Law, and Business Law. Several lecturers have competencies in other fields as: Advocates, Mediators, Legal Auditors, Contract Drafting Experts, Legal Drafting, and Capital Market Legal Consultants.*
